### Context

ecent developments in India have attracted wide global attention not only in terms of their substance and articulation but also in the context of systemic changes that have contributed to ongoing economic and social transformation and improvements in 'ease of living' besides attempting behavioural and attitudinal changes. The shift from entitlement based approach to expansion of a globally competitive entrepreneurial base; shifting of unorganised sector to organized commercial sectors; and growing emphasis on industrialisation with less carbon footprint characterise an evolving growth strategy, aided by digitalisation and innovation, with special focus on localisation and financial inclusion.

While the Government agencies and public institutions, in partnership with private sector, are making extensive efforts at executing new policy initiatives, a simultaneous effort is needed to analyse the impact of the new trajectories for capturing a micro level development perspective, which can be globally shared for possible replication. This effort, obviously, requires a new ecosystem of institutions, including the critical role of civil society organizations, Think-Tanks and other entities to study the role and linkage of private and public sectors in India and other developing countries in this important process.

It is also well established that development processes in any country can no longer be seen exclusively through an economic lens, particularly since contemporary research shows the undeniable relevance of social, political, cultural and institutional factors in determining the dynamics of holistic development for the evolution of an ecosystem based on plurality of experiences.

As quality development has to be the key outcome of cooperation among the nations of the South in the backdrop of growing level of inter-linkages, the emergence of GDC fulfils the long-felt need of developing countries to have a credible platform for collection, exchange and assimilation of knowledge and development experiences of India and others for undertaking through joint research studies and capacity building well grounded on the broad principles of equity, sustainability and inclusivity through multi-disciplinary and multi-functional approach. The new narrative on development emerging from India and other parts of the world has to be captured for a realistic understanding of the current growth strategy in this field for its horizontal dissemination across Global South.

The success of this endeavour largely depends on the engagement of its partner institutions, including relevant government agencies, Think-Tanks and civil society organizations having core competence and specific sectoral strengths to capture and promote possible replication of viable, transformative and affordable national development experiences and learning among developing countries for their accelerated economic development and collective self reliance.

# **Broad Vision**

- GDC aims to institutionalize India's development initiatives as part of knowledge sharing in Asia, Africa and Latin America with the help of its institutional partners.
- It intends to explore and articulate global development processes within a micro framework to collate and assimilate learning process of other countries towards promotion of equity, sustainability and inclusivity based on multidisciplinary and multifunctional approach.
- It strongly supports industrialization and diversification with less carbon footprints and growth strategy aided by digitalization and innovation with special focus on localization and financial institution.
- It attempts to study the role and linkage of the private and the public sector in India and in its partner countries for evolving well grounded development strategies.
- It intends to promote joint studies for collection, exchange and assimilation of knowledge and development experiences of India and other countries.
- It also aims to bring to India the successful experiences and initiatives of other countries for their possible absorption in India's development assistance strategies.
- It would strongly promote the establishment of workable linkages with various national and international institutions working on related areas.
- It would encourage evidence based research methodologies and case studies in its key domain areas, including Health, Quality Infrastructure, Science Technology and Innovation, Global Governance, Agriculture, Gender and Youth.
- It aims to evolve a new development narrative and create an ecosystem based on plurality of experiences along with sharing of India's development experiences with partner countries.

- It also aims to steadfastly work within the country and partner institutions and countries towards the realization of Agenda 2030.
- The key focus of its research programmes is to assist the developing countries in the fulfilment of their needs in accordance with their specific development priorities and requirements without any pre-conditions and work towards increased South-South and Triangular Cooperation.

# **Leveraging the Strength of RIS**

- RIS has a long history of engaging in the study and analysis of developmental issues globally. There is great synergy between the objectives of GDC and the RIS work programme. GDC is closely linked with the pioneering work of its various platforms such as the Forum for Indian Development Cooperation (FIDC) a tripartite initiative for collaborative action with the engagement of civil society organizations, academia and government policymakers and shapers since 2013.
- Similarly, GDC partners with its platform for global debate on issues related to South-South Cooperation and Triangular Cooperation called the 'Delhi Process' which captures the opportunities and challenges linked to development cooperation with special emphasis on South-South Cooperation. It distils the collective Southern view of development for global policy makers.
- In addition, the Network of Southern Think-Tanks (NeST) is also leveraged by the GDC for optimising its programme objectives and goals. The FIDC and the NeST, in particular, play a catalytic role in articulating Southern development models which can complement the GDC's efforts.
- The GDC also effectively disseminates its research and best practices through the Development Cooperation Review (DCR), a peer-reviewed journal on development issues.
- GDC is also well connected with its other major platforms such as Science Technology and Innovation Policy (STIP) Forum, BIMSTEC Network of Policy Think-Tanks (BNPTT), South Asia Centre for Policy Studies (SACEPS), BRICS Academic Forum, IBSA Academic Forum, Indian Technical and Economic Cooperation Programme (ITEC), IBSA Fellowship, RIS-EXIM Bank Summer School, and Internship Programme at RIS.

- GDC envisions as a bona fide platform of emerging practices, concepts and narratives of South-South Cooperation and Triangular Cooperation. It is also establishing a new ecosystem of institutions consisting of governments, Think-Tanks, civil society organisations and the private sector to form coalitions on global best practices. Therefore, GDC is pursuing meaningful partnerships with international/national agencies are being pursued.
- In order to amplify, as part of GDC's institutional outreach and bring on board subject experts and policy makers, GDC conducts high level capacity building programmes for officials and practitioners from other developing countries. GDC is also connecting with prominent global governance forums for showcasing its achievements and widen partnerships for greater impact. It has prominently participated at the Paris Peace Forum and Global Goals Week, 2021-22 at Dubai.
- GDC also promotes localisation of SDGs and encourages cross-learning among Indian States on multifaceted development initiatives and experiences by connecting different stakeholders like government, academia, think-tanks, civil society organisations, etc.
- GDC organizes academic and policy dialogues in the form of workshops and conferences; and brainstorming sessions and public seminars with partner agencies of other developing countries from time to time.
