Background Note

The adoption of three major international agreements viz. the 2030 Agenda and the SDGs, has necessitated the need for agricultural sector to look for innovative pathways towards enhancing global food and nutritional securities especially in more challenged, deprived regions. With the impacts of growing climate changes on the production systems and decreasing natural resources, solutions offered by technology based innovative pathways offer some promise. However, the adoption of such disruptive means, need a more informed and consensus approach to ensure better equity and reduce economic divides among regions. While some progress has been made in a few SDG areas like poverty reduction, child health, access to electricity, gender equality perspectives and agricultural productivity, more focus is needed for reducing inequalities, bettering nutritional security, building more access to food, lowering carbon emissions, protecting the rich biodiversity and bringing innovative sustainability models into practice in the agricultural sector. In effect, the 2020 pandemic has widened these SDG gaps leading to an increase in multidimensional vulnerabilities.

The Think 20 engagement under G20 platform offers a unique opportunity to deliberate the issues at policy advocacy level across stakeholder countries and suggest unique models of deployment. As India takes over G20 Presidency from Indonesia, it continues to address spillover effects of the pandemic, emerging geo-political crisis, climate change adversities along with the broader goal of accelerating the goals of SDGs. The theme of The India G20 Presidency as “One Earth, One Family, One Future” and the emphasis on “Lifestyle for Environment” have set the mandate towards a coherent agenda of sustainable development, climate action and climate justice. This is in line with the 2013 Group of Twenty (G20) leaders’ declaration of “the importance of boosting agricultural productivity, investment and trade to strengthen the global food system to promote economic growth and job creation”.

The essence is to focus on productivity – enhancing investment and the integration of small holders into markets for not only food and nutritional security but also for enhanced livelihood models leading to economic growth. The SDGs offer a blue print for achieving sustainable global prosperity. A balanced economic growth and sustainable development requires that this sector reduce ecological footprint by innovative models of production-consumption agri-food systems. Among the several stakeholders, the new crop of technology developers and entrepreneurs offer solutions for a more inclusive growth across agri-food value chain leading to higher level of wellness and healthy populations.



Against this background, the one-day side-event titled “Building Innovation-led Entrepreneurial Pathways for Acceleration the Reach to SGDs” under Task Force 6 of T-20 engagement for G-20 seeks to get engaged with agri-professionals, innovators, startups, innovative farmer, industry, investors, policy makers and other stakeholders. Policies for the SDGs need to be designed with an aim to reach the last vulnerable individual in line and implemented with humane principles at their core. To deepen sustainability efforts, issues such as climate smart agriculture, biodiversity conservation and sustainable blue economy, and water conservation continue to be areas needing more focus. Revitalizing the modalities of development cooperation in its various forms remains critical to the attainment of the SDGs by 2030.

AgHub, PJTSAU, Hyderabad in partnership with Global Developmental Centre, Research and Information Systems (RIS), New Delhi, and IKP Knowledge Park, Hyderabad is organizing a one-day event consisting a varied discussion platform with Government officials, policy makers, thematic experts, researchers, and innovators across the subthemes that encompass SDG goals towards food and nutritional security, climate resilience, and wellness. A varied platform for panel discussions, startup exhibitions expert talks will form part of workshop. The objective is give all stakeholders an opportunity to help build an actionable framework towards accelerating pathways through innovations. We see a potential through this workshop to offer the T20/G20 platform, ‘a stakeholder-driven actionable framework of new innovation-led pathways’ and accelerate the reach to SGDs.

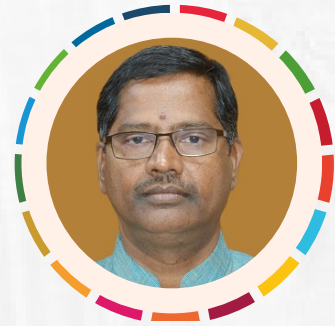

The Rural Innovation Spokes cater to rural innovators and entrepreneurs seeking to promote rural entrepreneurship among rural youth, women, grassroots innovators, farmers & FPOs in Tier-II and Tier-III towns of the State of Telangana. AgHub is a Section-8 Company registered as a non-profit under the Indian Companies Act. It is a Rural Business Incubation Centre funded with the earnest support of NABARD. Till date AgHub has nurtured ~45+ Food & Agritech startups, 1500+ Design Thinkers, 500+ Ideas, ~ 10 rural enterprises, 20 grantees, ~2 seed funded startups and is impacting the lives of ~5000 farmers in the region.

TF-6: Accelerating SDGs: Exploring New Pathways to the 2030 Agenda

Policies for the SDGs need to be designed keeping in mind how to reach the last individual in line, so that the most vulnerable are also the most sought after. These policies must be implemented with humane principles at their core. To deepen sustainability efforts, issues such as climate smart agriculture, biodiversity conservation and sustainable blue economy, and water conservation need to be addressed. For issues ranging from food and nutrition for all to universal digital access to inclusive healthcare to broad-based financial products, how can the G20 countries create/strengthen institutions and collaborations? Their challenges may also include providing health infrastructure and holistic healthcare leveraging traditional systems of medicine. While gender outcomes remain a cause for concern, women-led development processes require significant policy support to promote entrepreneurship and allied fields so as to increase female labour force participation. Recent reversals in SDG achievement caused by the pandemic and the ensuing economic crisis have brought the focus back on societal resilience. Science, Technology, and Innovation, and technology facilitation for SDGs remain key means of implementation as outlined in the Addis Ababa Action Agenda (AAAA) and the Agenda 2030. Hence, revitalising the modalities of development cooperation in its various forms remain critical to the attainment of the SDGs by 2030.

Think20 (T20), as an official G20 Engagement Group, was initiated during the Mexican Presidency in 2012. It serves as an “idea bank” for the G20 by bringing together think tanks and high-level experts to discuss relevant international socio-economic issues. T20 recommendations are synthesized into policy briefs and presented to G20 working groups, ministerial meetings, and leaders’ summit to help the G20 deliver concrete policy measures.

Under Think20, **Seven** Task Forces are in place. These are:

TF-1: Macroeconomics, Trade, and Livelihoods: Policy Coherence and International Coordination.
